Entrepreneur: Entrepreneur is the person who undertakes risk, mobilizes resources and explores new ideas to transform into business venture.

Entrepreneurship: Entrepreneurship is the process of designing, launching and running a new business based on creative, innovative idea.

Incubator: Incubator is a place or situation that permits or encourages the formation and development of new ideas and supports new businesses to grow by providing training, consultancy and funding.

Innovation: Innovation can refer to something new or to a change made to an existing product, idea, or field.
